Minutes of the Williamson County Historical Commission

A regular meeting of the Williamson County Historical Commission was held on September 12, 2019 in the Williamson County Courthouse at 700 Main Street, Georgetown, Texas. Eloise Brackenridge served as Chair and Rachel Arnold served as secretary.

The Chair called the meeting to order at 4:00 p.m.

Minutes:

The Chair called for review of the minutes of the July11, 2019 meeting. Nancy Bell changes needed to be made to the "Website" and "New Business" sections of the minutes. The secretary recognized and agreed to clarify any confusion.

Treasurer's Report:

Nancy Bell reported that the WCHC FY20 budget was approved at \$1,600 for the General Fund.

\$7.53 in the remaining in the FY19 General Fund. \$6 to be used for Google and Wayne is returning the \$1.53 to the Williamson County General Fund. Program Fund balance is \$7,132.86, Tombstone restoration balance is \$343.67 and \$100 of unrestricted funds. Jane donated \$100 from Park Meadow Nursing home that will be added to unrestricted funds.

Old Business:

Nancy did an open records request to the City of Leander requesting information regarding the Pioneer House in Leander. Through the receipt of the information, it was discovered that the Federal Highway Administration (FHWA) is the enforcement authority of the MOA. Nancy motioned that the WCHC contact the FHWA to make them aware of the City of Leander's failure to accept the deed; Rachel Arnold seconded the motion. Mickie Ross then asked if the WCHC had reached out to the City of Leander. It was determined that the WCHC had not. Rachel Arnold rescinded her second. The original motion died for lack of a second. Rachel Arnold then motioned that the WCHC reach out to the City of Leander with in the next week to schedule a meeting with leadership. Mickie Ross seconded the motion. The motion passed 13-1. Mickie Ross and Eloise Brackenridge stated that they would like to attend the meeting with Rachel and Nancy.

Committees Reports:

Markers -

Final wording for the Post Oak Island maker. Charlene has approved that. No other markers are in the works.

Cemeteries -

Wayne and Shelby visited the Gordon Cemetery. There is an Eagle Scout that would like to rehabilitate the cemetery. WCHC is going to be the beneficiary

Boy Scouts want to help at the Mt Horeb Cemetery. They may do a fence and a permanent sign as the other signs have been stolen in the past.

Nowak Cemetery where Johnson grass is nearly seven feet tall. They cleared out the grass near the tombstones. The father from Dallas was not able to come, but the CRV (Cemetery Restoration Volunteers) we able to work. They plan to continue working as temperatures cool.

Circleville Cemetery had all the tombstones broken. The CRV worked to repair them, but some were stolen.

The View is going to do a story on the CRV. They need more volunteers.

The committee discuss the potential of getting donations to give as a reward to get information about cemetery vandalization.
